RMCLT COVID-19 Response March 18, 2020

In the interest of the health and safety of RMCLT staff and clients, we are taking the following measures to minimize exposure and spread of the COVID-19 virus:

- RMCLT offices will be closed to all walk-in clients.
- RMCLT staff will be available to read and reply to email during normal business hours Monday through Friday and will have limited access to phones during those times.
- RMCLT is cancelling Orientations through April 2nd. The next scheduled Orientation is April 16th. Appointments for one on one orientations can be made on a case by case basis as circumstances dictate.
